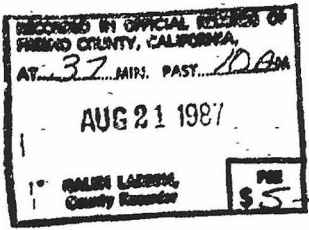

THIRD AMENDED
DECLARATION OF RESTRICTIONS

DOGWOOD MOUNTAIN TRACT NO. 2294

FRESNO COUNTY RECORDERS OFFICE

THIS THIRD AMENDED DECLARATION IS MADE THIS 15th day of August, 1987, by DOGWOOD MOUNTAIN ASSOCIATION, a California corporation (Declarant), in light of the following facts and circumstances:

Legal Description of Little Shuteye Lane (extension)

THIS IS A CORRECTION description of an easement 40.00 feet in width, for Public Utilities and Private Road for Public Use purposes over and across portions of Lots 27, 28, and 29 as shown on the Map of Tract No. 2294, Shaver Falls, recorded in Volume 27, of Plats at Pages 9 thru 14, Fresno County Records, the center line of which is described as follows:

Commencing at a point on the North line of said Lot 27 which bears N84°28'E, 57.00 feet from the Northwest corner thereof; thence from said point of commencement as follows: S70°44'40"E, 116.38 feet; S66°17'53"E, 73.69 feet; S52°26'02"E, 103.84 feet; S80°46'38"E, 120.73 feet to the center of a turnaround whose radius is 30.00 feet; thence continuing along said centerline from the center of said turnaround as follows: S80°20'59"E, 160.76 feet; N66°18'52"E, 229.76 feet; N88°44'18"E, 150.34 feet; S54°01'E, 142.90 feet, and S30°40'18"E, 166.75 feet to a point on the north line of Lot 30 which bears N89°12'51"W, 23.45 feet from the northeast corner thereof, said point being the end of the centerline of this easement.
